- No complaints or applications will be accepted after 4:00 PM on 23rd January 2025.
- As per Section 7 of PMDC regulations 2023, candidates with less than 60% marks in HSSC/equivalent or less than 55% in MDCAT 2023 & 2024 are ineligible for admission to MBBS. Similarly, candidates with less than 50% marks in MDCAT 2023 & 2024 are ineligible for admission to BDS.
- As per PM&DC Act 2023 Section 17(4) "The MDCAT result of one province shall be valid for the entire country and shall be valid for a period of three years. Each province, Gilgit-Baltistan and Islamabad Capital Territory shall give preference to the students having domicile of their respective province or territory as the case may be."
